EASEMENT AND CONSTRUCTION AGREEMENT

This Easement and Construction Agreement (AGREEMENT) is entered into by and between the Mississippi Transportation Commission, (COMMISSION), by and through the duly authorized Executive Director of the Mississippi Department of Transportation, (MDOT) and the Madison County Board of Supervisors, Mississippi, (COUNTY), acting by and through its duly authorized Board of Supervisors, (COUNTY), effective as of the latest date of execution below.

WITNESSETH:

WHEREAS, the COMMISSION proposes to reconstruct Interstate 55 (I-55) beginning 0.7 mile south of Gluckstadt Road and extending in a northerly direction a distance of approximately 1.5 miles, to a point approximately 0.8 mile north of Gluckstadt Road, including Gluckstadt Road Interchange; and

WHEREAS, the COMMISSION has prepared plans and specifications for the proposed construction, said plans being designated as Federal Aid Project Number NH-0055-02(214) / 103063 - 301000, Madison County, relevant excerpts of which are attached hereto, and the entirety of which are on file in the office of the COMMISSION in Jackson, Mississippi, reference to which is for all purposes as if copied herein in words and figures (see attached plats and exhibits); and

WHEREAS, the COUNTY is the current owner of the property or the easements underlying all local streets, except a portion of Calhoun Station Parkway, shown on said plans and specifications; and

WHEREAS, the COMMISSION has requested permission from the COUNTY to make certain adjustments, relocations, and grade changes to all known COUNTY streets which now cross, connect, or are adjacent to the referenced construction project; and

WHEREAS, the COUNTY has agreed to this request and both parties desire to evidence this AGREEMENT by written instrument.

NOW, THEREFORE, in consideration of the promises and agreements of the parties hereto and hereinafter contained, as shown below, it is hereby agreed as follows:

The **COMMISSION** shall:

- 1. Construct by contract said section of I-55 in accordance with the plans and specifications for Federal Aid Project Numbers NH-0055-02(214) / 103063 301000.
- 2. Be responsible for the maintenance of all roadway, rights of way, and traffic control devices within the limits of the construction project in accordance with the MDOT policies, rules, and regulations for the duration of the project.
- 3. Acquire all rights of way left and right of centerline as required by the plans for said section of I-55 not previously acquired by the COUNTY.
- 4. Be responsible for overseeing all utility adjustments.
- 5. Maintain all right of way secured for this project, to include that portion of reconstructed and/or relocated COUNTY streets within the right of way secured, but not to include the right of way to be returned by the COMMISSION to the COUNTY, or the right of way acquired by MDOT and to be deeded by the COMMISSION to the

COUNTY at the completion of the project. Specific reconstructed and/or relocated COUNTY streets (i.e., that portion of all existing COUNTY street right of way beyond the normal right of way only) to be returned to the COUNTY, and to be deeded to the COUNTY (i.e., all COUNTY street right of way acquired by MDOT for this project, and all specified previously existing MDOT right of way) are as follows:

- (a) That portion of **Dee's Drive Connector** from Dee's Drive to Station 170+20 (+/-) and as shown in greater detail on Sheet 8 of 15. The aforementioned property shall maintain no access status as shown on the attached drawing.
- (b) That portion of **Relocated Gluckstadt Road** west of I-55 between Station 17+74 and Station 22+70 (+/-) and as shown in greater detail on Sheet 9 of 15. The aforementioned property shall maintain no access status as shown on the attached drawing.
- (c) That portion of Gluckstadt Road east of I-55 between Station 42+00 and Station 44+00 (+/-) right of centerline and between Station 45+17 (+/-) and Station 49+50 (+/-) right of centerline and as shown in greater detail on Sheet 10 of 15. The aforementioned property shall maintain no access status as shown on the attached drawing.
- (d) That portion of Gluckstadt Road east of I-55 between Station 40+70 (+/-) and Station 41+15 left of centerline and Industrial Drive Extension east of I-55 between Station 155+20 (+/-) at Gluckstadt Road and Station 161+34 (+/-) and extending eastward along Gluckstadt Road to Station 50+00 and as shown in greater detail on Sheet 11 of 15.

The **COUNTY** shall:

- 1. Release the COMMISSION from any and all damages arising, or to arise in its favor and on its account as a result of the COMMISSION altering, relocating or changing the grade of intersecting streets along said project or the altering, or changing the grade of any other street including existing streets, unplatted streets or unopened streets in any location adjacent to said project.
- 2. Hereby grant, convey and warrant unto the COMMISSION an unlimited easement on, over and across all COUNTY street rights-of-way and COUNTY owned property within the right of way limits and/or construction limits as shown on the plans for Federal Aid Project Number NH-0055-02(214) / 103063 301000 for the purpose of constructing and maintaining the aforesaid project. See attached drawings on Sheets 12 and 13 of 15.
- Upon completion of construction of the designated improvements on all COUNTY streets, assume responsibility for all maintenance of all portions of said adjusted COUNTY streets and traffic control devices as described above upon notice from the COMMISSION.
- 4. Accept and record the deeds to all Right-of-Way conveyed by the Commission.
- 5. At the completion of the project, deed to the COMMISSION the portion of COUNTY right of way described as follows:

- (a) That portion of **Gluckstadt Road** west of I-55 between Station 22+70 (+/-) and Station 23+20 right of centerline and between Station 26+85 and Station 75+50 (+/-) right of centerline as shown in greater detail on Sheet 14 of 15.
- (b) That portion of **Gluckstadt Road** east of I-55 between Station 37+68 (+/-) and Station 42+00 and as shown in greater detail on Sheet 15 of 15.




RIGHT OF WAY ACQUISITION MAPS






RIGHT OF WAY ACQUISTION MAP




Relocated Gluckstadt Road (West) at Calhoun Station Parkway




Gluckstadt Road (East) - Right Side




Industrial Drive Extension & Gluckstadt Road (East)




