Attachment to Articles of Incorporation of Old Town Wesley Chapel of Ridgeland

This Attachment and the electronic form it accompanies constitute the Articles of Incorporation of Old Town Wesley Chapel of Ridgeland (the "Corporation") pursuant to Section 79-11137 of the Mississippi Nonprofit Corporation Act, Mississippi Code of 1972, Section 7911-101, et seq., as amended (the "Act"). The purpose of this Attachment is to supplement the electronic form to include additional provisions and comply with the Act:

- 1. The purpose or purposes for which the Corporation is formed are to spread the Gospel of Jesus Christ, which should include but not be limited to the following:
- (a) The promotion of the Christian religion through the preaching of the Word of God, the administration of the sacraments, ordinances, and other means of grace, the maintenance of worship, the edification of believers, empowering Christians to live lovingly and justly in the power of the Holy Spirit, the evangelization of the world, and the promotion of the missionary and benevolence causes.
- (b) Receiving, holding, and disbursing gifts, bequests, and funds arising from all sources.
- (c) Acquiring, owning, and maintaining real estate, buildings, and other. property real or personal, incidental, necessary, or proper to carry out said objects.
- (d) Doing of any and all things necessary or incident to the accomplishment of such purposes.
- (e) The powers and rights of this corporation shall be all the general powers enumerated in Section 79-11-151 of the Act as now in effect or as hereafter may be amended. The powers and rights include but are not limited to those as are reasonably necessary to accomplish its stated purposes and objects, including, but not limited to, those rights and powers set forth elsewhere herein and also the following: the power to adopt all necessary bylaws not contrary to law and these Articles or any amendment thereto; prescribe the manner of calling and conducting meetings; elect officers and directors and prescribe their duties, compensation and tenure; sue and be sued; contract and be contracted with; adopt a corporate seal; receive, donate, sell and convey real and personal property; borrow money and secure the payment of same by mortgage or otherwise; purchase, own, hold, donate, sell, transfer, assign, mortgage, pledge, or otherwise dispose of and deal in the stocks, bonds,

securities, or evidences of indebtedness of other corporations, public or private, of any state or government, including bonds or securities of any state or political subdivision thereof.

- 2. The Corporation shall have no voting members. Full control and management over the activities and affairs of the corporation shall be vested in the Board of Directors.
- 3. Upon the filing of these Articles all the rights, privileges, immunities, powers, franchises, authority, property, and obligations of First United Methodist Church, Ridgeland an unincorporated not for profit association, shall thereupon pass to, vest in, and be the rights, privileges, immunities, powers, franchises, authority, property, and obligations of the Corporation.
- 4. No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 3(a) hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate' in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501 of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code
- 5. Upon dissolution of the Corporation, the Board of Directors shall, after paying or making provision for payment of all of the liabilities of the Corporation, dispose of all of the assets of the Corporation exclusively for the purposes of the corporation in such manner or to such organization or organizations organized and operated exclusively for religious, charitable, scientific, literary and/or educational purposes as shall then qualify as an exempt organization or organizations under Section 501 (c)(3) of the Code, as the Board of Directors shall determine in its discretion, Any such assets not disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the Corporation is then located, provided however that such court has determined that the disposition is made exclusively (i) for the purposes constituting the corporation's basis for exemption or (ii) to an organization or organizations exempt from taxation under Section 501 of the Code.
- 6. The provisions of the Articles of Incorporation may be amended or modified from time to time in accordance with the Act; provided that no provision shall be amended or modified in such a manner as to be inconsistent with the objects and purposes for which this Corporation is formed or which would cause the Corporation no longer to be described in Section 501 (c)(3) of the Code
- 7. The Corporation is intended to be an organization (i) that is exempt from federal income tax under Code Section 501(c)(3) and (ii) to which contributions are deductible under Code

Section 170(c)(2). The provisions of these Articles shall be interpreted and construed accordingly.
