I would like to extend my sincere gratitude to you, your staff and the Madison County Board of Supervisors for your support as the Executive Director of Madison County Citizens Services Agency (MCCSA). Your assistance greatly impacts the citizens of Madison County.

I would like to request a \$983,666.00 allocation from the Madison County Board of Supervisors for the FY 2024-2025. We did not request an increase in funding last fiscal year. We are requesting an \$327,902.00 increase in our allocation this year. This increase is due to our MDOT match increased from \$512,608.00 in 2024 to \$880,388 in 2025 due to vehicle insurance and inflation. These funds will be used primarily to match and leverage the federal grants. Our request is composed of non-payroll items in the amount of \$765,809.00 (78%), salaries and fringes of \$197,857.00 (20%), and a \$20,000.00 board adjustment, making our total request \$983,666.00.
