

SELECTED VTD BOUNDARY DESCRIPTIONS
MADISON COUNTY, MISSISSIPPI

All Corporate Limit lines are as of April 2020.

529 DEERFIELD

Commence at the intersection of the centerlines of State Highway 43 and Yandell Road, located near the center of the north half of Section 22, Township 08 North, Range 03 East;

thence run northwesterly and northerly along the centerline of State Highway 43 a distance of approximately 2.75 miles, to the centerline of Endris Road, located near the center of the north line of Section 9, Township 08 North, Range 03 East;

thence run westerly along the centerline of Endris Road a distance of approximately 1.75 miles, to the centerline of a high voltage power transmission line right-of-way, located near the center of the north line of the northeast quarter of Section 7, Township 08 North, Range 03 East;

thence run southwesterly along the centerline of said high voltage power transmission line right-of-way a distance of approximately 1.68 miles, to the centerline of North Old Canton Road, located near the center of the west line of Section 18, Township 08 North, Range 03 East;

thence run southerly along the centerline of North Old Canton Road a distance of approximately 1.50 miles, to the centerline of Cedar Grove Lane, located near the southwest corner of Section 19, Township 08 North, Range 03 East;

thence run easterly and northeasterly along the centerline of Cedar Grove Lane a distance of approximately 800 feet, to the centerline of Yandell Road;

thence run easterly and northeasterly along the centerline of Yandell Road a distance of approximately 3.65 miles, to the centerline of State Highway 43, located near the center of the north half of Section 22, Township 08 North, Range 03 East, this being the POINT of BEGINNING.

408 FELLOWSHIP BIBLE CHURCH

Commence at the intersection of the centerline of Interstate 55 North and Gluckstadt Road, located near the center of the south line of the southwest quarter of Section 21, Township 08 North, Range 02 East;

thence run northerly and northeasterly along the centerline of Interstate 55 North a distance of approximately 3.32 miles, to the centerline of Ragsdale Road, located near the north line of Section 10, Township 08 North, Range 02 East;

thence run easterly along the centerline of Ragsdale Road continuing easterly along an extension of the centerline of said Ragsdale Road a distance of approximately 1.25 miles, to the intersection of the centerlines of US Route 51 and Nichols Road, located near the center of the north line of the northeast quarter of Section 11, Township 08 North, Range 02 East;

thence run easterly, northerly, and northeasterly along the centerline of Nichols Road a distance of approximately 1.30 miles, to the centerline of North Old Canton Road, located near the center of Section 1, Township 08 North, Range 02 East;

thence run southeasterly along the centerline of North Old Canton Road a distance of approximately 3,200 feet, to the centerline of Endris Road, located near the northeast corner of Section 12, Township 08 North, Range 02 East;

thence run easterly along the centerline of Endris Road a distance of approximately 4,350 feet, to the centerline of a high voltage power transmission line right-of-way, located near the center of the north line of the northeast quarter of Section 7, Township 08 North, Range 03 East;

thence run southwesterly along the centerline of said high voltage power transmission line right-of-way a distance of approximately 3.32 miles, to the centerline of Yandell Road, located near the center of the south line of the southwest quarter of Section 24, Township 08 North, Range 02 East;

thence run westerly and southwesterly along the centerline of Yandell Road a distance of approximately 2.15 miles, to the intersection of the centerlines of US Route 51 and Weisenberger Road, located near the center of the northwest quarter of Section 27, Township 08 North, Range 02 East;

thence run westerly and northwesterly along the centerline of Weisenberger Road a distance of approximately 1,150 feet, to the centerline of the main line of the Canadian National Railroad right-of-way, located near the center of the west line of the northwest quarter of Section 27, Township 08 North, Range 02 East;

thence run northeasterly along the centerline of said main line of the Canadian National Railroad right-of-way a distance of approximately 1,850 feet, to the centerline of a southeasterly extension of the centerline of Old Jackson Road, located near the northwest corner of Section 27, Township 08 North, Range 02 East;

thence run northwesterly along the centerline of said southeasterly extension of the centerline of Old Jackson Road a distance of approximately 350 feet, to the centerline of Gluckstadt Road, located near the southwest corner of Section 22, Township 08 North, Range 02 East;

thence run southwesterly and westerly along the centerline of Gluckstadt Road a distance of approximately 4,250 feet, to the centerline of Interstate 55 North, this being the POINT of BEGINNING.

528 FAIRVIEW M.B. CHURCH

Commence at the intersection of the centerlines of Clarkdell Road and Green Oak Lane, located near the southeast corner of Section 34, Township 08 North, Range 02 East;

thence run easterly along the centerline of Green Oaks Lane a distance of approximately 375 feet to the centerline of North Old Canton Road and continue easterly and northeasterly a distance of approximately 1.93 miles to the centerline of Dave Brown Road, located near the center of the southeast quarter of Section 36, Township 08 North, Range 02 East;

thence run southerly along the centerline of Dave Brown Road a distance of approximately 1,375 feet, to the centerline of Gray Hill Road, located near the center of the north line of the northeast quarter of the northeast quarter of Section 1, Township 07 North, Range 02 East;

thence run easterly and southeasterly along the centerline of Gray Hill Road a distance of approximately 3,950 feet, to a point on the northern shoreline of an inlet of the Ross Barnett Reservoir, located near the center of the northwest quarter of the northeast quarter of Section 6, Township 07 North, Range 03 East;

thence run southeasterly along the meandering centerline of the northern shoreline of said inlet of the Ross Barnett Reservoir a distance of approximately 1,125 feet, to a point on the centerline of the Natchez Trace, located approximately 1,825 feet South 24 Degrees West of the northeast corner of Section 6, Township 07 North, Range 03 East, said point being located near the center of the northeast quarter of Section 6, Township 07 North, Range 03 East;

thence run southeasterly along a constructed imaginary line, trending South 68 Degrees East a distance of approximately 3,885 feet, to a point on the east boundary line of Madison County, located near the center of Section 5, Township 07 North, Range 03 East;

thence run northeasterly along the meandering eastern boundary line of Madison County a distance of approximately 7.50 miles, to the centerline of State Highway 43, located near the center of the northeast quarter of Section 25, Township 08 North, Range 03 East;

thence run northerly, westerly, and northwesterly along the centerline of State Highway 43 a distance of approximately 2.60 miles, to the centerline of Yandell Road, located near the center of the north half of Section 22, Township 08 North, Range 03 East;

thence run southwesterly and westerly along the centerline of Yandell Road a distance of approximately 3.65 miles, to the centerline of Cedar Grove Lane, located near the southwest corner of Section 19, Township 08 North, Range 03 East;

thence run southwesterly and westerly along the centerline of Cedar Grove Lane a distance of approximately 800 feet, North Old Canton Road;

thence run northerly along the centerline of North Old Canton Road a distance of approximately 1.50 miles, to the centerline of a high voltage power transmission line right-of-way, located near the center of the west line of Section 18, Township 08 North, Range 03 East;

thence run southwesterly along the centerline of said high voltage power transmission line right-of-way a distance of approximately 1.63 miles, to the centerline of Yandell Road, located near the center of the north line of the northwest quarter of Section 25, Township 08 North, Range 02 East;

thence run westerly and southwesterly along the centerline of Yandell Road a distance of approximately 2.15 miles, to the centerline of to the intersection of the centerlines of US Route 51 and Weisenberger Road, located near the center of the northwest quarter of Section 27, Township 08 North, Range 02 East;

thence run westerly and northwesterly along the centerline of Weisenberger Road a distance of approximately 1,150 feet, to the centerline of the main line of the Canadian National Railroad right-of-way, located near the center of the west line of the northwest quarter of Section 27, Township 08 North, Range 02 East;

thence run northeasterly along the centerline of said main line of the Canadian National Railroad right-of-way a distance of approximately 1,850 feet, to the centerline of a southeasterly extension of the centerline of Old Jackson Road, located near the northwest corner of Section 27, Township 08 North, Range 02 East;

thence run northwesterly along the centerline of said southeasterly extension of the centerline of Old Jackson Road a distance of approximately 350 feet, to the centerline of Gluckstadt Road, located near the southwest corner of Section 22, Township 08 North, Range 02 East;

thence run southwesterly and westerly along the centerline of Gluckstadt Road a distance of approximately 4,250 feet, to the centerline of Interstate 55 North, located near the center of the south line of the southwest quarter of Section 21, Township 08 North, Range 02 East;

thence run southwesterly along the centerline of Interstate 55 North a distance of approximately 2.30 miles, to the centerline of Bear Creek, located near the center of the southeast quarter of Section 31, Township 08 North, Range 02 East;

thence run southeasterly and northeasterly along the meandering centerline of Bear Creek a distance of approximately 1.85 miles, to the centerline of a certain drainage canal, located near the center of the southeast quarter of the northeast quarter of Section 32, Township 08 North, Range 02 East;

thence run southeasterly along the meandering centerline of said drainage canal running South 33 Degrees East a distance of approximately 5,021 feet, to the centerline of US Route 51, located near the center of the northeast quarter of the northwest quarter of Section 4, Township 07 North, Range 02 East;

thence run northeasterly along the centerline of US Route 51 a distance of approximately 2,725 feet, to the centerline of Green Oak Lane;

thence run southeasterly and easterly along the centerline of Green Oak Lane a distance of approximately 1.45 miles, to the centerline of Clarkdell Road, located near the southeast corner of Section 34, Township 08 North, Range 02 East, this being the POINT of BEGINNING.
