In accordance with Sections 37-61-9 and 37-57-104 of the Mississippi Code of 1972 (Ann.), please see enclosed two copies of the budget for Canton Public School District for the 2024-2025 fiscal year as well as the resolution approving the budget.

Our funding request for this year totals \$22,046,103.01. A total of \$18,114,867.01 is requested for operations; and a total of \$3,931,236.00 is requested for debt. Based on information we received from Madison County tax offices, which was previously shared with you, no new millage will have to be levied to meet this request. However, we respectfully request that the proper millage be set to meet the funding request. Let me know if you have any questions.

# RESOLUTION APPROVING THE SY 2024-2025 BUDGET, SALARY SCHEDULE, AND SALARIES FOR EMPLOYEES OF THE CANTON PUBLIC SCHOOL DISTRICT, CANTON, MADISON COUNTY, MISSISSIPPI

WHEREAS, the Superintendent of the Canton Public School District has prepared his annual budget of estimated expenditures for the support, maintenance, and operation of the Canton Public School District for the fiscal year commencing July 1, 2024; and

WHEREAS, a notice of the public hearing to provide the general public with an opportunity to comment on the taxing and spending plan incorporated in the proposed budget was published once each week for two consecutive weeks in the *Madison County Journal*, a newspaper having general circulation within the Canton Public School District, a proof of publication of which shall be maintained in the file folder of the meeting and made a part hereof by reference; and

WHEREAS, the Board of Trustees held a public meeting at 4:00 P.M. on June 26, 2024 at which time the proposed budget for SY 2024-2025 was presented to the public; and

WHEREAS, the Board of Trustees finds that the budget submitted by the Superintendent for SY 2024-2025, provides for total revenues to be received by the District to be in the amount of \$57,787,209.79 of which the sum of \$22,046,103.01 is to be received from local ad valorem tax effort; and

WHEREAS, the Board of Trustees request that the City of Canton, Mississippi and Madison County, Mississippi, the levying authorities for the District, assess all real and personal property lying within the Canton Public School District with a sufficient ad valorem tax to produce the sum of \$22,046,103.01 in local ad valorem taxes, and

WHEREAS, the Board of Trustees further finds that the proposed SY 2024-2025 budget should be finally approved; and

WHEREAS, the Board of Trustees further finds that the salary schedules incorporated into the budget and the salary schedules of all District employees, a copy of which shall be kept in the file folder of this meeting, should be ratified and approved.

THEREFORE, BE IT RESOLVED, that the SY 2024-2025 budget for the Canton Public School District ,which has been signed by the Chairman and Secretary of the Board, and a copy of which shall be kept in the file folder of this meeting, should be, and hereby is, finally approved pursuant to the provisions of §37-61-9, Miss. Code Ann. (1972).

BE IT FURTHER RESOLVED that the salary schedule for all District employees, a copy of which shall be kept in the file folder of this meeting, is incorporated into the budget and all salaries are hereby ratified and approved.

BE IT FURTHER RESOLVED that the Superintendent should be, and hereby is, authorized and directed to deliver two certified copies of the approved budget to the levying authority for the Canton Public School District pursuant to §37-61-9, Miss. Code Ann. (1972) with the requests that the levying authority assess all real and personal property lying within the Canton Public School District with a sufficient millage rate to produce the sum of \$22,046,103.01 in ad valorem taxes for the 2024-2025 school year.
