The Madison County Board of Supervisors hereby approves salary increases for all Madison County employees not employed by the Madison County Sheriff's Office or the 20th Circuit District Attorney. The increase for any employee not excluded shall be 5% of the employees' annual pay if the annual pay is less than \$50,000 and 3% of the employees' annual pay if the employee's annual pay is greater than \$50,000. The raises shall take effect for the first payroll period of Fiscal Year 2025 which begins October 6, 2024.
