Dear Members of the Board:

I am requesting your consent for 3 of our youth court staff (Alicia Louisville, Anya Rucker, Avis Stringer) and myself to attend the Annual Mississippi Juvenile Justice Symposium on August 6-8, 2025 in Biloxi, Mississippi. This conference satisfies continuing educational requirements as well as an opportunity for our staff to be updated on the latest developments in juvenile justice diversion and rehabilitation.

**Registration** for the conference is \$345 per person. Please see the registration attached as Exhibit A along with the conference W9 attached as Exhibit "B." We have already registered our participants to ensure a lower conference fee. If approved by the Board, the fees can be paid by check or with credit card.

**Hotel** – If approved, Judge O'Neal will be responsible to prepay her own room and will submit a reimbursement request in the amount of \$363.87 in the usual manner.

Rather than asking employees to prepay expenses, I am requesting that the three remaining reservations for two nights (8/6 and 8/7) for Louisville, Rucker and Stringer be made by the County purchasing department at the conference group rate if there is availability but for no more than \$185 a night including all taxes and fees. Information about the conference block of rooms is attached as Exhibit "C."

I would request that this amount plus mileage and meals be spent first from budget line items 001.163.487 and 001.163.480 until exhausted and then from 001.162.487 and 001.162.480 if necessary.
