We have reviewed the bids received on July 11, 2025, at 2:00 p.m. at the Office of the County Administrator for the above-mentioned Project. We have found the submitted bid proposals and information to be in accordance with the requirements of the project specifications and submittal requirements. In addition, we offer the following:

- Please refer to attached Certified Bid Tabulation for summary of bids received.
- The Base Bid from Ramsay Construction Group, Inc. was \$993,100 and Alternate #1 was \$137,000, for a total of \$1,130,100.00, with Unit cost #1 at \$8 psf and Unit cost #2 at \$4 psf.
- The Base Bid from The Lathan Company, Inc. was \$935,500 and Alternate #1 was \$62,500, for a total of \$998,000, with Unit cost #1 at \$4 psf and Unit cost #2 at \$3 psf.
- The Lathan Company is a non-resident bidder but has submitted the required bid preference law with their bid, which mirrors the Mississippi Law.

Belinda Stewart Architects has contacted The Lathan Company and confirmed that they are satisfied with their submitted bid. Based on the bid and their experience on similar projects, Belinda Stewart Architects recommends award of the project and Alternate #1 to The Lathan Company for a total of \$998,000.
