THEREFORE, in accordance §31-7-1 et seq. and as the Madison County Board of Supervisors' officially named designee to declare emergencies, I, Greg Higginbotham, do hereby declare an emergency exists concerning the air conditioner for the holding/receiving area at the Madison County Detention Center. This declaration shall only be applicable to expenditures incurred by the Madison County Board of Supervisors related to replacing the failing chillers.
