This letter is in response to your request for contractor eligibility dated July 29, 2025, for the following: Anding Construction Services, LLC, 104 Noble Drive, Brookhaven, MS 39601-3624.

The Community Incentives Division of the Mississippi Development Authority has received your submitted documentation requesting the referenced contractor's status of being debarred, suspended or ineligible from Federal Procurement and Non-Procurement Programs. The Compliance Bureau did not find the contractor ineligible; therefore, the contractor is eligible to participate in the above-mentioned project.

The "Start of Construction and Contractor Award Notification Form" must be submitted to the appropriate Program Manager prior to the first construction draw. A representative from the Community Incentives Division has the discretion to attend the Pre-Construction Conference. Please submit HUD Form 4710, "Semiannual Labor Compliance Report," for projects requiring compliance with Davis-Bacon and Related Acts as contracts are awarded.

The Madison County Board of Supervisors must adhere to the Section 3 regulatory requirement found at 24 CFR 135 of the Federal regulation. It also must ensure to the "greatest extent feasible" that economic opportunities, employment, and job training are provided to Section 3-covered residents and businesses within the community, as a result of the federally funded construction project.
