

POLLING LEASE AGREEMENT

THIS AGREEMENT made this the ____ day of _____, 2025 by **Mount Pleasant M.B. Church** in Gluckstadt, Mississippi, hereinafter referred to as "Lessor" or "Church" and **Madison County, Mississippi**, hereinafter referred to as "Lessee" or "County."

IT IS AGREED, as follows, to-wit:

1. **AGREEMENT TO LEASE:** Lessor shall grant and Lessee shall accept to lease the certain structure known as Mount Pleasant M.B. Church and the premises surrounding said church located at 729 Gluckstadt Road, Gluckstadt, Mississippi, for a term not to exceed three (3) days for each general, primary, run-off and special election conducted by the County at a daily rental of One Hundred Dollars (\$100.00) per day pursuant to Mississippi Code Annotated, Section 23-15-259 (1972).

2. **TERMS AND TERMINATION OF LEASE:** The term of this lease shall begin December 1, 2025 and continue for a period of four (4) years. Thereafter, the Lease shall be extended automatically for one (1) year terms unless notice is given in writing to terminate by either party. Lessor or Lessee may terminate thereof, upon providing the other party of written notice of said terminating party's intent to end said Agreement. This notice must be delivered and received by the other party at least one hundred eighty (180) days prior to the date which said termination shall become effective to allow Lessee sufficient time to have a new polling place for voters and provide required notice.
