## NOTICE OF A PUBLIC HEARING ON THE PROPOSED BUDGET AND PROPOSED TAX LEVIES FOR THE UPCOMING FISCAL YEAR FOR MADISON COUNTY, MISSISSIPPI

The Madison County Board of Supervisors will hold a public hearing on its proposed budget and proposed tax levies for fiscal year 2026 on September 2, 2025, 9:00 a.m. in the Board Room of the Chancery/Administrative Office Complex, 125 West North Street, Canton, Mississippi.

The Madison County Board of Supervisors, exclusive of the Madison County School District, is now operating with projected total budget revenue of \$179,598,435.43. Of that amount, 38.6 percent or \$69,483,141 is proposed to be financed through a total ad valorem tax levy. For the next fiscal year, the proposed budget has total projected revenue of \$204,984,498.71. Of that amount, 34.13 percent or \$69,978,278 is proposed to be financed through a total ad valorem tax levy.

The Madison County Board of Supervisors, inclusive of the Madison County School District, is now operating with projected total budget revenue of \$397,207,823.22. Of that amount, 38.7 percent or \$153,895,721.48 is proposed to be financed through a total ad valorem tax levy. For the next fiscal year, the proposed budget has total projected revenue of \$400,884,057.92. Of that amount, 37.9 percent or \$151,935,057.95 is proposed to be financed through a total ad valorem tax levy.

For next fiscal year, the Madison County Board of Supervisors plans to **not increase your ad valorem tax millage** rate for property outside of the Southwest Madison County Fire Protection District

For next fiscal year, the Madison County Board of Supervisors, at the request of the Southwest Madison County Fire Protection District Board plans to increase your ad valorem tax millage rate in the Southwest Madison County Fire Protection District by 4.0 mills, a total increase of \$100,470 in additional ad valorem tax collections. This increase means you will pay more in ad valorem taxes on your real property.

A millage rate of 36.95 mills will produce the same amount of revenue from ad valorem taxes as was collected in the 2025 fiscal year. The millage rate for the 2025 fiscal year was 38.13.

The decision to not increase the ad valorem tax millage rate for fiscal year 2026 above the current fiscal year's ad valorem tax millage rate means you will not pay more in ad valorem taxes on your home, automobile tag, utilities, business fixtures and equipment and rental property outside of the Southwest Madison County Fire Protection District, unless the assessed value of your property has increased for fiscal year 2026.

Any citizen of Madison County, Mississippi is invited to attend this public hearing on the proposed budget and tax levies for fiscal year 2026 and will be allowed to speak for a reasonable amount of time and offer tangible evidence before any vote is taken.
