RESOLUTION TO LEVY TAX MILLAGE FOR FISCAL YEAR ENDING SEPTEMBER 30, 2026

WHEREAS, the matter of determining the tax levy for the Fiscal Year 2025–2026, under the general authority as set forth in Section 21-33-45 of the Mississippi Code of 1972, came before the Mayor and Board of Aldermen of the Town of Flora, Mississippi; and

WHEREAS, it has been determined that a tax levy is necessary to meet the financial needs of the Town for the fiscal year ending September 30, 2026;
NOW, THEREFORE, BE IT RESOLVED by the Mayor and Board of Aldermen of the Town of Flora, Mississippi, that there is hereby levied a tax of 34.50 mills, allocated as follows:

General Fund	34
Library Fund	.5

SO RESOLVED this the 21st day of August, 2025. Motion was made by Alderman Lunsford, and seconded by Alderman Jenkins, for the adoption of the above and foregoing Resolution.
