RE: Auction Proposal

Dear Supervisors,

Thank you for allowing us to submit a proposal to you. Enclosed is the list of equipment that will be sold at auction. Our proposal is as follows:

- 1. We will guarantee a price of \$752,000 for the entire package of equipment. Anything over the guarantee will be split 70% for Madison County and 30% for Thomas Auction (example the guarantee is \$752,000 and the equipment brings \$802,000 at the auction, the split of the extra \$50,000 would be \$35,000 for Madison County and \$15,000 for Thomas Auction. The total to Madison County would be \$752,000 + \$35,000 = \$787,000).
- 2. We will sell the equipment on or before December 6, 2025, and pay the county within 15 business days of the auction.
- 3. We will pick up and haul the tractors and road grader for no additional fee. The County would be responsible for getting all the trucks and dump trailers to our lot in Kosciusko.
- 4. We will clean any item that needs to be cleaned for no additional fee.
- 5. We will make any small repairs that would increase the value of an item but only with approval from the County (one truck needs a starter, some of the trucks will need batteries, one truck needs a rear yoke, one truck has a bad air leak). We will charge you our cost for these repairs, but we will get approval first. The cost for repairs will be held out of the final settlement so the County will not be out any money.

Your items will be listed on Truckpaper.com, Tractorhouse.com, Machinerytrader.com, and auctiontime.com
