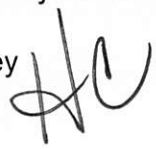

Re: Election Workers – November 4, 2025

Behind this memo is a list of individuals identified by the Madison County Election Commission as scheduled to work polling places for the November 4, 2025 election. We have certified that these election workers are eligible to work and receive payment.

Please take the following actions:

1. Approve the individuals on the attached list as poll workers for the election and authorize payment of two hundred dollars (\$200) as authorized by MS Code 23-15-227.
2. Approve additional fees as allowed by MS Code Section 23-15-227 for workers designated as poll managers including:
 - a. Twenty-five dollars (\$25) for each manager carrying to the place of voting, away from the courthouse, the official ballots, ballot boxes, pollbooks, and other necessities...for each voting precinct",
 - b. Twenty-five dollars (\$25) for each manager acting as the "returning officer";
 - c. Mileage reimbursement for a person who acts as either (a) or (b) above in the event the individual uses a "privately owned motor vehicle" and "travels in excess of ten (10) miles.

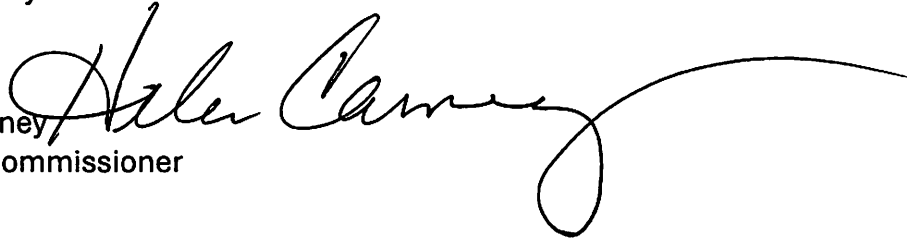

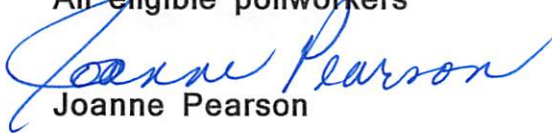
