WHEREAS, the undersigned has been advised by Madison County Chief Deputy, Jeremy Williams, and Madison County Sheriff Randy Tucker, that the pneumatic lock system in the Madison County Detention Center is failing, and the failure of the lock system poses a risk to the safety of county employees and inmates in the county's care. The delay incident to giving the opportunity for competitive bidding would be detrimental to the interests of the County.

THEREFORE, in accordance with §31-7-1 et seq. and as the Madison County Board of Supervisors' officially named designee to declare emergencies, I, Greg Higginbotham, do hereby declare an emergency exists concerning the locks at the Madison County Detention Center. This declaration shall only be applicable to expenditures incurred by the Madison County Board of Supervisors related to replacing the failing pneumatic lock system.

We are having numerous issues with the locks on the cells in the main jail. As you are aware, the current system that operates the pneumatic locks is deteriorating. We are constantly having to call the facility manager to break into the cells when they are not operating properly. This is leaving inmates in the cell with no way to get to them if an emergency arises. The air system that operates the doors along with the 24-volt system is deteriorating. This is most definitely a life safety issue that needs to be addressed immediately.
