Re: ALL RISE CONFERENCE

Dear Members of the Board:

The Youth Court Drug Treatment Courts have been awarded grant funds for our staff join the ALL RISE conference (including membership) on **July 19-July 23, 2026** in Nashville, Tennessee. This is a valuable online and in person resource for our staff, and we are fortunate to have been awarded funding for this purpose.

Please place the following items on the next agenda for acknowledgement and consent:

1. **Membership Fees:** The County will need to pay this in advance before registration can be completed at the discounted price. Invoices for each staff member are attached as well as a receipt for one that has been prepaid.
 - a. Pay the Membership fee of \$60 per person for Latanya Allen, Ashley Alexander and Steven Ross, Amy Nisbett, Staci O'Neal from Fund 185-163.
 - b. Pay the Membership fee of \$60 per person for Jamie Ballard, , and Steven Stafford from Fund 186-163.
2. **Conference Fee:** The County will need to pay this in advance by June 26, 2026.
 - a. Pay the Conference fee of \$860 per person for Latanya Allen and Steven Ross from Fund 185-163. **The deadline to get this price is June 26, 2026.**
 - b. Pay the Conference fee of \$860 per person for Jamie Ballard, Amy Nisbett, and Steven Stafford from fund 186-163. **The deadline to get this price is June 26, 2026.** Once the membership fee is paid, the conference will send me an invoice.
3. **Mileage/Airfare:** Each person will book their own flights and get reimbursed after traveling.
 - a. Approve mileage or airfare from Fund 185-163 to Nashville up to \$750 per person, Latanya Allen and Steven Ross.
 - b. Approve mileage or airfare from fund 186-163to Nashville up to \$750 for Jamie Ballard, Amy Nisbett, and Steven Stafford.
4. **Accommodation:** The County will need to book this in advance.

- a. Accommodation for four (4) nights during the conference (July 19, 2026 to July 23, 2026). The hotel allowance shall not exceed more than \$250 a night for Latanya Allen and Steven Ross from Fund 185-163.
 - b. Accommodation for four (4) nights during the conference (July 19, 2026 to July 23, 2026). The hotel allowance shall not exceed more than \$250 a night for Jamie Ballard, Amy Nisbett and Steven Stafford from Fund 186-163 at the Homewood Suites This booking must be made electronically.
5. The appropriate per-diem rate for 5 days for each staff member mentioned above.
