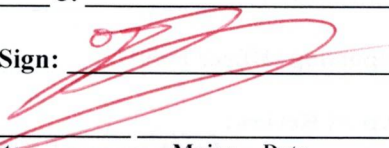
Narrative

On 08/03/2026 I Captain Strait received a phone call from Fallen the mother of released inmate Nyema Olle-Coleman. She told me that her daughter was missing a pair of diamond earrings I told her that I would look at video and get back with her as soon as I found out what happened. Myself and LT. Jessica Olson looked through video and found where the intake accrued. We noticed the intake was not done correctly by Officer Little. We followed the inmate throughout the jail and found where Officer Little took the earrings from the inmate in interview 2. Officer Little then takes the earrings to booking and tapes them to the wrong inmates board. We verified this by calling booking officer Smith who told us that inmate Kewanis Jefferson did have earrings taped to her property board. I have asked the mother to send me a receipt for the purchase of the earrings so I can get a check to her.
