FYI, the Town of Flora held a pre-con meeting with the contractor on Tuesday, and has given him a notice to proceed date of Monday, March 31, 2014. During the pre-con the contractor noted that due to the depth of the ditch and depending on the actual depth of the utility lines, he believes we will run over our boring quantity some amount. We currently have $300 \square \square$ set up for both bores, but the contractor thinks it will actually be closer to $335 \square \square$. This could increase the cost of the project by approximately \$3000.

As you are aware, the quantities we put in these proposals are strictly an estimate, but I just wanted to make sure you and the County were aware of this up front in case the final contract amount ran over a little.
