Gentlemen:



2. Award to Peppers Erosion Control the term bid for Mulching, all quantities.
3. Reject the bid of Scott Johnson Specialty Services LLC for Clearing and Grubbing due to the bidder’s failure to follow the bid specifications and instructions. The bid was not submitted on the required bid sheet and required pay items not listed in the specifications such as mobilization.


