Securus Technologies

For an extended period of time, Madison County has been purchasing phone cards for resale to inmates from Securus Technologies. We have purchased these cards at discounted rates based on terms allowed by the Federal Communications Commission (FCC). The historical discount has been 46%.

Unknown to Madison County, the FCC changed the computation of the allowable discount for transactions after February 1, 2014.

In February, Madison County issued two purchase orders under the historical terms, using a 46% discount. Securus has now informed Madison County that the discount must change to 44.43% on these orders.

Please see the accompanying explanatory memo from the Sheriff's Department.

After conferring with Board Counsel and seeking informal advise from Office of State Auditor, I am requesting that the Board of Supervisors find that Madison County must comply with Federal Law and Regulations and that the invoice in excess of the purchase order be paid to comply with such regulations.

Dear Mr. Vance:

The Federal Communication Commission (FCC) has mandated new rate caps on interstate calls for companies that provide telephone services to prison inmates, effective February 11, 2014, which changed our trade discount rate from 46% to 44.43%. A copy of letter from Securus Technologies is attached. Here is additional information from Securus: "The adjustment to the current PPCC Discount was calculated as follows:

- 1. We determined the percentage of all PPCC activity over the past 12 months that was processed as 'Interstate Traffic' to have been 3.41%.
- 2. To properly weight this percentage against the current discount rate the following formula was applied:

(1 - 0.0341) * 0.46 = 0.4443"

Currently there are two outstanding invoices where the purchase orders were submitted with the old discount rate. Therefore, the purpose of this letter is to request the Madison County Board of Supervisors to issue a check for the new invoice amount of \$5001.30, a difference of \$131.30. From this date forward, all future purchase orders and Securus invoices will reflect the new invoice amount.

Thank you in advance for your consideration and processing this request.

RE: Billing Impacts of FCC Ruling on Interstate Calls

To Our Valued Customers,

In accordance with Federal Communications Commission 47 CFR Part 64 [WC Docket No. 12-375; FCC 13-113] – Rates for Interstate Calling Services – effective February 11, 2014, the Federal Communications Commission (FCC) has mandated new rate caps on interstate calls for companies that provide telephone services to prison inmates. The FCC's new caps include interstate calls rated at \$0.21 per minute for debit calls and \$0.25 per minute for collect calls. Without limitation, these rates will go into effect without anything required on behalf of our customers. Due to the FCC's Order, Securus no longer will pay site commissions on interstate calls.

This FCC change will go into effect on February 11, 2014. As such, Securus must modify our billing policies as follows:

For Interstate, Traditional Collect and Direct Bill Calling:

- Interstate call rates will be set at \$0.25 per minute

For Interstate, AdvanceConnect and Debit Calling:

- Interstate call rates will be set at \$0.21 per minute

For customer who use Securus SCP Debit:

- Interstate call rates will be set at \$0.21 per minute
- Correctional Facilities' SCP Debit usage invoice will be adjusted to eliminate Facility
- discount on interstate debit calls beginning on February 11, 2014

Prepaid Calling Cards:

- Beginning February 11, 2014, all Prepaid Calling Card discounts will be reduced by the percent of interstate calling revenue used on prepaid cards over the past 12 months.
 - o Example:
 - Facility Prepaid Calling Card discount (before) = 30%
 - Facility percent of interstate calling revenue = 5%
 - Adjusted Facility Prepaid Calling Card discount = 28.5%

Due to the FCC ruling, Securus will be changing the way in which prepaid cards are invoiced and commissioned. These new changes may include selling cards at face value (vs. net of discount) and subsequently paying commissions on the actual usage, as is typical with other products. These decisions have not been formalized but will begin with additional notice in 2014.

In accordance with Securus' published price list, some fees will continue to apply to interstate calls separate from the new FCC mandated calls rates.
