BOARD MEMBERS ABSENT: MARCUS GOODLOE


The meeting was called to order by President Willie Cline. Invocation was done by Mr. Alonzo McGruder. The reading of the minutes from last meeting was done by Ms. Tecora Goines. Mrs. Dorothy Draine motioned that the minutes be approved as read with the necessary corrections. The motion was second by Mr. Alonzo McGruder and then carried.

Mr. Alonzo McGruder motioned that the millage for the Valley View Fire Department should be three (3) mills, for upcoming budget year. The motion was second by Ms. Tecora Goines. All board members present and via phone conference agreed that three (3) mills will be the millage for Valley View Fire Department. Board member Marcus Goodloe voted via phone conference. President Willie Cline will be responsible for delivering the millage letter to Mr. Mack Pigg.

President Willie Cline and Mr. Alonzo McGruder will take inventory of all equipment that has been purchased by the Valley View Fire Department. The board members came to an agreement that board meetings will be held the 3rd Tuesday of each month at 6:00 p.m.

Open House held on February 22, 2013 was a success, total cost for food was \$350.00 leaving \$31.19 in the non-appropriated fund. The balance for the appropriate fund is \$3985.61. The board approved that Mr. Marcus Goodloe purchase flashlights, fire flaps, and five vests from the Southern Connection at a price not to exceed \$500.00.
