At the District meeting on March 11, 2014, a request was put forward by Chief Wilkerson that the District request one of the Sheriff Department's cars that are being decommissioned. He stated that a captain for the Southwest Volunteer Fire Department, Captain Ben Hawthorn, was a paramedic and could use the vehicle when responding to calls. Minimally, it is expected to shave 15 to 30 minutes off response time to fire calls and accidents since all the medical and monitoring equipment can be stored in the car thereby cutting out a trip to the station first to get equipment.

We, the Southwest Madison County Fire Protection District Board, respectfully request that one of the Crown Victoria's be donated to the District to enhance our ability to respond in a timely manner and to improve our service to the community.
