Madison County Veteran Service Officer Annual Report to the County Board of Supervisors 2013 - 2014



On behalf of the 5,927 Veterans and numerous deceased veteran's widows, we thank each of you for your continuing support. I also thank you for allowing me to be your Veteran Service Officer for the last, almost, 11 years. During this time we have had over 5000+ veteran contacts. This past year we had a total of 718 veteran/widow contacts. Older veterans continue to die...1,000's a day. However, the number of veterans in our county continues to grow. In 2011 Madison County had 5,073 veterans.

The total of VA expenditures for Madison County this past year was \$32,535.00. A copy of all counties is included with this report.

I continue to serve on the VA Hospital Management Council. We meet with the Center Director, Joe Battle and his Chief of each department on a regular basis. I have assisted designing and erecting Veterans monuments. I also have acted as Master

of Ceremonies at 2 events. I was fortunate to speak to several Veterans Organizations.

In addition to being accredited representative of the National Association of Veteran Service Organization, I am also accredited with the Military Order of the Purple Heart, the Organization for Disabled Veterans, the Retired Enlisted Association and the Vietnam Veterans of America for the preparation, presentation, and prosecution of claims before the Department of VA under the laws relating to veterans benefits.

I continue to be a lobbyist to the MS Legislature representing MS Association of County Veterans Service Officers. I was fortunate to introduce and pass a law to allow the designation of Veterans on driver's license which gives proof he was a Veteran. It also allows him to get a 10% discount at Lowes, Piccadilly, etc.

I would like to introduce Susan Little, our Associate Veteran Service Officer. I would also like to introduce a special guest, Joe Battle. He is the Center Director at the Sonny Montgomery VA Medical Center who will make a few remarks.

In concluding, please except my Resolution for Memorial Day on May 26, 2014.

VA hospital, director can be trusted and should be commended

This column is in response to an article written by Fred Lucas stating, "Veterans no longer trust the VA hospital care."

It is my understanding that Lucas retired from the VA many years ago and was well respected for his work; however, his statements are misleading, false and hearsay.

Director Joe Battle is to be commended for his excellent leadership. Many of the altercations are dating back to 2007 and 2009. All have been investigated and resolved.

In radiology, there were two complete rounds of investigations, and several external reviews were conducted; no patients were harmed. In two cases, where errors may have occurred, veterans and their families were informed.

In reference to sterile processing, over \$1 million in new sterile processing equipment was purchased in 2010. This situation was reviewed by the joint commission on accreditations, the Office of Inspector

General and OSHA, with no significant recommendations.

Please also note that there are those veterans who want the VA hospital privatized and will never be pleased until that happens.

When the parking situation was brought to Joe Battle's attention, he made arrangements to have 200 employees park off site, freeing up 200 new parking spaces for veterans. Security reports to Battle two times a day the number of vacant parking spots.

There are no problems that are minor to Battle. He has dedicated his life to providing the best care for the veterans.

In reference to the ratio of nurse practitioners to doctors, Lucas' comments stated that this ratio was 3-to-1. In fact, it is 1.5-to-1 ratio. Two more doctors started in November, and the ratio will be 12 nurse practitioners to 10 doctors (almost 1-to-1).

One of the first priorities
Battle established was the
Management Assistance Council meetings with congressional staff and the Veterans Service Organization. This council meets quarterly. I am a member of this council.

The September meeting was from 11 a.m. to 2 p.m. The agenda included House Veterans Affairs Committee field hearing, an update on Office of Special Counsel complaints, recruitment updates, homeless veterans programs update, AmeriCorps partnerships for veteran recruitment, close out of fiscal year, and comments and concerns from veteran service officers and organizations. We were also introduced to several new department

heads, new medical staff members and two administrative assistants.

Last year, working in Canton, I had 902 veteran contacts. VA expenditures for the past year in Madison County was \$35 million.

Under Battle's management of the hospital and medical clinics, he supervised new construction with \$1.7 million for mental health units, \$1.6 million for oncology renotations, \$1.4 million for sico renovations and \$1.2 million for women veterans clinic renovations. Under his leadership and outreach, programs included a women's vet clinic, homeless vet program, mental summit and job fairs mobile in 12 towns.

Mississippi has the fewest doctors per capita in the U.S. Doctors, as all federal employees, have to be vetted, and income for VA physicians is lower than their civilian counterparts. However, Battle has hired several new doctors.

Difficulty in hiring new

physicians is not true. Battle has hired five new doctors over the last few months, including a women's health director. It has been stated that Battle has received a bonus when, in fact, he has not received a bonus since he has been here.

Veterans can trust the VA hospital; all employees, doctors and management are dedicated to excellent patient care.

I will close by saying the following from a Shake-speare's Julius Caesar: Anthony says, "the evil that lives after them, the good in men inferred in their bones," so let it be with VA hospital; the human errors that VA does will live forever, and the good is often forgotten. Let all good stand out.

Proposed Canton annexation

CANTON - Mayor Arnel Bolden said as the city continues to pursue different annexation avenues they wouldn't approve a proposal that would increase the annual budget by over \$1.5 mil-

"That number is a false projection," he said. "We've

reviewed at least 2-3 proposals to annex areas. They vary in size and scope.

"Once the board and I get together to look at cost factors, as well as look at a particular plan that has been presented to us, then we can decide which plan can be the best course of action," he continued.

"We don't anticipate allowing ourselves to accept a proposal that would increase our budget

by \$1.9 million. That would not be smart."

Bolden said different proposals would result in annexation of between 2-5 square miles.

The proposal obtained by the Journal showed an increase of land area by 64 percent, street miles by 52 percent and population by 33 percent.

The proposal stated increased revenue of over \$660,000, with over \$460,000 coming from
