## Automated Charge Back Codes

## Februarry Batch will Include:

- Code 2 Applicant or applicant's spouse claimed to be a resident of another state for income tax purposes
- Code 5 Applicant is not a natural person (deceased per Social Security Death Index)
- Applicant or applicant's spouse has failed to comply

  Code 35 with the income tax laws of Mississippi (Delinquent

  State Income Tax Debt)
- Code 36 Property with no residence is not eligible (Zero building value reported)

## Delinquent Income Tax Charges

Applicants charged for delinquent income taxes can ONLY have their homestead reinstated if they were in compliance by February 1 of the year following the year they are seeking homestead exemption.

Example: Taxpayer is delinquent in state income tax for Income Tax Year 2010. Taxpayer has until February 1, 2014, to get into compliance in order to have his homestead reinstated for Tax Year 2013.
