Cultural Resources Survey and Wetlands Reports have been completed and submitted. MDAH had accepted the CRS. I had been told that Canton did not want to proceed with the right-of-way acquisition until all environmental approvals were obtained. I will check with State Aid to find out if they have received an approval on the wetlands report.

Cane Creek Road LSBP-45(12):

Last week I asked State Aid to review the plans that they have on the shelf and let me know if anything needs to be updated.

The wetlands report for the project is supposed to be complete Monday, June 2.

I learned yesterday that the relocation of the Town of Flora utilities has been completed.

Once we submit the wetlands report and update any items that State Aid identifies, this project should be ready to go to bid.
