# Manual Charge Back Codes

## June Batch will Include (APPLICATION ISSUES):

- Code 8 - Application is incomplete causing eligibility to be undeterminable. (Application missing REQUIRED data)
- Code 9 - Application was not filed by April 1.
- Code 10 - Application was not signed by applicant or his spouse and a copy of written authority as not attached to the application.
- Code 11 - Signature of applicant was not acknowledged by Tax Assessor or his deputy.
- Code 31 - Applicant did not hold eligible title to this property on January 1.
- Code 32 - The instrument by which applicant claims title to this property was not of record as of January 7.

# Manual Charge Back Codes

## June Batch will Include (OTHER):

- Code 12 - Applicant or applicant's spouse was allowed exemption on other property (multiple homesteads).
- Code 20b - An assessed value exceeding \$7,500 was allowed on the supplemental roll. (Excess of limits violation – county)
- Code 46 - There is an error in the amount of reimbursement requested which is limited to \$200 per applicant. (Excess of limits violation – municipality)
- Code 48 - Noncompliance with provisions of laws, rules and regulations. (ROLL ERRORS – affects county ONLY)
