Dear Board Members:

The Twentieth Circuit Court District Adult Drug Court is funded by a grant through the Administration of Courts (AOC). We also collect monthly drug court fees from our participants. That money is put into our "Local Drug Court Fund" which is managed by Madison County. For our budget that covers July 1, 2014 to June 30, 2015 we were awarded a grant from the AOC in the amount of \$100,000.00. In addition to that, AOC is requiring us to match 20% of that from our Local Drug Court Fund in the amount of \$25,000.00. Attached is a copy of our grant award and budget for FY2014-2015.

On November 13, 2014 we received an email from AOC informing us that we are required to spend the \$25,000.00 out of our Local Drug Court Fund before the budget year is out. We simply wanted to make sure the Board is aware that we will be spending money that we have collected in our Local Drug Court Fund to cover part of our budget for this year. Also attached is a copy of the email from the AOC.

Dear Judge Hannan,

On June 6, 2014, the State Drug Court Advisory Committee met to discuss the allocation of state drug court funds. I'm pleased to inform you that the Twentieth Circuit Drug Court will qualify for reimbursements not to exceed \$100,000.00 for the period of July 1, 2014, to June 30, 2015. In order to receive the full amount from the state drug court fund, you must commit to provide a 20% match. In your case, that would mean providing \$25,000.00 from your local drug court fund in order to receive the \$100,000.00 in state funds. Your total budget, therefore, would be \$125,000.00 for FY2015.

Compliance with the Mississippi Drug Court Rules and Mississippi Drug Court Fiscal Policy, in addition to the Alyce Griffin Drug Court Act, Miss. Code Ann. §§ 9-23-1 to - 23, is required to continue to receive reimbursement from the state drug court fund.

Coordinators:

In your FY2015 budget approval letter, it stated that your drug court would be required to contribute 20% of your overall approved budget from local or county funds. Many of you have met or exceeded that 20% requirement. However, with 1/3 of the fiscal year complete, quite a few of you have contributed little or no local funding to the overall budget of the drug court. As coordinators, you are expected to ensure that the drug court follows the rules and policies established by the State Drug Court Advisory Committee. Therefore, the required 20% contribution will be enforced beginning with January reimbursements. The AOC will begin deducting 20% (or more) from each AOC expenditure request until the required match is met. If you are in this category, you will probably want to get with your County Administrator (or whomever is in charge of finances) and advise.

The following is the local match requirements for Circuit Drug Courts:
