Road Claim for Yulonda Davis on Gluckstadt Road

The original investigation of this claim found a pothole in the vicinity of the location given by Yulonda Davis. That particular pothole had been repaired. That pothole was in the general area of 173 Gluckstadt Road. That pothole had been repaired recently but the date is unknown. During the investigation on the above referenced claim, and other previous claims, it was found that there were multiple potholes in the area on Gluckstadt Road between Hwy 463 and Dewees Road. It was not possible to ascertain which one was the one in question after the seven days had run due to the fact that that area had been under consistent pothole repair. That area has been the subject of several road claims and road repairs in the last several weeks. Therefore, it is the recommendation of the Emergency Management Office to approve and pay the claim to the order of Yulonda Davis in the amount of \$373.42 (the lesser of the two attached quotes) for stated repairs.
