In reviewing payroll for elected officials for 2014, an error in 2012 payments was detected for one Madison County elected official.

Sheriff Randy Tucker was not paid his full salary as Sheriff for the 2012 calendar year. He was paid the remainder of his wages for his role as Chief Deputy under then-Sheriff Toby Trowbridge and then 25 of 26 payments that should have been made to him as the newly-elected Sheriff. He was paid \$84,615.50 of his \$88,000 salary, leaving a balance of \$3,384.50.
