Subject: Award bid for Electronic Poll Books

Gentlemen:

The Board recently approved advertising for one or more Electronic Poll Books. The only bid was submitted by Election Systems and Software (ES&S). The price is \$983 per Electronic Poll Book and \$1,799 per 30-Unit Charging and Sync Station.

The Electronic Poll Books, which are about the size of an I-Pad, will serve multiple functions:

- (1) Replace the multiple copies of the paper poll books that Circuit Clerk Lee Westbrook currently prints for each election;
- (2) Replace the current paper voter sign-in sheets, as voters would sign-in with a stylus on the screen of the Electronic Poll Book;
- (3) The encoder card each voter receives to insert in the TSX voting machine will be automatically programed with the correct ballot style by the Electronic Poll Books instead of by a separate poll worker at a different table. This will insure accuracy and speed up the voting process;
- (4) If a registered voter goes to the wrong precinct, the Electronic Poll Books will provide the correct name and address of the voter's precinct;
- (5) Following each election, the Electronic Poll Books will save about two-weeks of work hours by quickly uploading the required record of who voted to the Secretary of State's system.

I met with Circuit Clerk Lee Westbrook, the Election Commission, and the ES&S salesman on Friday. Both Mrs. Westbrook and the Election Commission are in favor of purchasing 220 Electronic Poll Books and seven 30-unit Charging/Sync Stations.

It is my recommendation that the Board award the bid for Electronic Poll Books to

Election Systems and Software (ES&S) for 220 Electronic Poll Books at a cost of \$216,260 and seven 30-unit Charging/Sync Stations at a cost of \$12,593. The total purchase price is \$228,853.

This is a budgeted purchase. The machines will be delivered by March, which provides ample time for ES&S to train all parties prior to the this year's elections on how to use the Electronic Poll Books.
