PETITION TO REZONE AND RE-CLASSIFY REAL PROPERTY AND TO AMEND THE LAND USE PLAN OF MADISON COUNTY

- 1. Petitioner, Agnes W. Stanley, is the owner of a parcel of property to be rezoned, such parcel being described in **Exhibit "A"** attached hereto, and incorporated herein by reference.
- 2. Petitioner requests that the parcel be rezoned from its current classification of A-1 agricultural and reclassified as C-2 Commercial.
- 3. That the character of the neighborhood has changed to such an extent as to justify reclassification, and there is a public need for the rezoning.
- 4. The Land Use and Transportation Plan of Madison County designates the parcel as I-1.
- 5. The Land Use and Transportation Plan of Madison County, Mississippi must also be amended to reflect the rezoning.
 - 6. That the initial proposed use is for a private metal building to service tractor/trailers

and for parking of trailers.

WHEREFORE, PREMISES CONSIDERED, Petitioner requests that this Petition be received, filed and docketed, and that after a hearing hereon, the Board of Supervisors of Madison County, Mississippi will enter an Order rezoning and reclassifying the property described in Exhibit "A" from A-1 Agricultural to C-2 Commercial, and reflecting such change on the Land Use and Transportation Plan of Madison County, Mississippi.

LEGAL DESCRIPTION "A"
