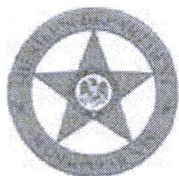
Shelton:

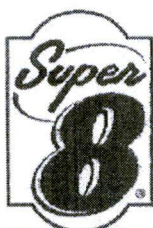
