SUBJECT: Claim Rejection (Roger Dabbs Chevrolet)

State law requires a purchase order to be issued for any purchases over \$1,000.00. Madison County received two invoices from Roger Dabbs Chevrolet for an optional towing packages. The purchase orders were issued based on state contract data; which did not indicate the cost of the larger wheels that were required with the optional towing packages. Per state law we do not have authority to pay these invoices.
