Bids for the above referenced project were opened at 10:00 am on April 21, 2015. There were a total of 4 bids received, and 4 no-bids. A certified bid tabulation is attached.

The apparent low bidder, Rowell Roofing submitted a base bid of \$144,900.00. There was 1 deductive alternate considered in the amount of (\$10,000.00) for only a partial asphalt shingle roof replacement. Because the bids are less than the budgeted amount, the deductive alternate is not in play.

To this date no protests have been received by this office. Therefore I recommend award of this project to Rowell Roofing without alternate 1 for a contract amount of \$144,900.00

Please be advised that because this is a renovation project, some degree of funding should be set aside as a contingency for undiscovered items that may arise during this roof replacement.
