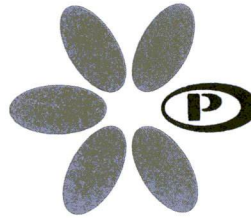

Re: Road Registry Change  
Matthews Ave.  
Canton, MS

Our office received a letter from Presto Industries (attached) inquiring about the correct road name for one of their locations, located within the city of Canton. The concern was if the correct name was "Matthews Avenue" or "Matthews Drive".

Upon investigating and consulting with the City of Canton, we learned that street sign actually is "Matthews Drive" and all of CMU's records reflect the same. Madison County did accept the name of the road as "Matthews Avenue" in the road registry; however somewhere along the line it was picked up as "Drive".

With confirmation from CMU, we are requesting that an official name change in the Madison County Road Registry be submitted, changing from "Matthews Avenue" to "Matthews Drive". We feel this avoid any further problems concerning this matter.

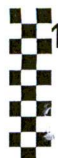
