ORDER REGARDING COMPENSATION OF OFFICIAL COURT REPORTERS

THIS MATTER came before the Court regarding compensation of the Official Court Reporters for the Twentieth Circuit Court District of Mississippi, Harvey J. Rayborn and Candice Simmons Crane.

Consistent with the applicable statute, the Court finds that beginning October 1, 2015, Harvey J. Rayborn be paid an annual salary of \$52,000.00, plus the usual benefits; that beginning October 1, 2016, Harvey J. Rayborn be paid an annual salary of \$58,000.00, plus the usual benefits; and that beginning October 1, 2017, Harvey J. Rayborn be paid an annual salary of \$64,000.00, plus the usual benefits, and further finds that such salary and benefits should be pro-rated between the counties of the district, with Rankin County paying sixty percent (60%) and Madison County paying forty percent (40%).


Consistent with the applicable statute, the Court finds that beginning October 1, 2015, Candice Simmons Crane be paid an annual salary of \$48,500.00, plus the usual benefits; that beginning October 1, 2016, Candice Simmons Crane be paid an annual salary of \$53,500.00, plus the usual benefits; and that beginning October 1, 2017, Candice Simmons Crane be paid an annual salary of \$64,000.00, plus the usual benefits, and further finds that such salary and benefits should be pro-rated between the counties of the district, with Rankin County paying sixty percent (60%) and Madison County paying forty percent (40%).

IT IS THEREFORE ORDERED AND ADJUDGED that Harvey J. Rayborn shall be compensated in the following amounts: beginning October 1, 2015, he be paid an annual salary of \$52,000.00, plus the usual benefits; beginning October 1, 2016, he be paid an annual salary of


\$58,000.00, plus the usual benefits; and beginning October 1, 2017, he be paid an annual salary of \$64,000.00, plus the usual benefits; and such salary and benefits shall be pro-rated between the counties of the district, with Rankin County paying sixty percent (60%) and Madison County paying forty percent (40%).

IT IS FURTHER ORDERED AND ADJUDGED that Candice Simmons Crane shall be compensated in the following amounts: beginning October 1, 2015, she be paid an annual salary of \$48,500.00, plus the usual benefits; beginning October 1, 2016, she be paid an annual salary of \$53,500.00, plus the usual benefits; and beginning October 1, 2017, she be paid an annual salary of \$64,000.00, plus the usual benefits; and such salary and benefits shall be pro-rated between the counties of the district, with Rankin County paying sixty percent (60%) and Madison County paying forty percent (40%).
