ORDER REGARDING COMPENSATION OF OFFICIAL COURT REPORTERS

THIS MATTER came before the Court regarding compensation of the Official Court Reporters for the Eleventh Chancery Court District, Mary Helen Walden and LaTanya Allen.


Consistent with the applicable statute, the Court finds that beginning October 1, 2015, Mary Helen Walden be paid an annual salary of \$52,000.00, plus the usual benefits; that beginning October 1, 2016, Mary Helen Walden be paid an annual salary of \$58,000.00, plus the usual benefits; and that beginning October 1, 2017, Mary Helen Walden be paid an annual salary of \$64,000.00, plus the usual benefits, and further finds that such salary and benefits should be pro-rated between the counties of the district, with Madison County paying eighty percent (80%) and Leake County paying twenty percent (20%).

Consistent with the applicable statute, the Court finds that beginning October 1, 2015, LaTanya Allen be paid an annual salary of \$52,000.00, plus the usual benefits; that beginning October 1, 2016, LaTanya Allen be paid an annual salary of \$58,000.00, plus the usual benefits; and that beginning October 1, 2017, LaTanya Allen be paid an annual salary of \$64,000.00, plus the usual benefits, and further finds that such salary and benefits should be pro-rated between the counties of the district, with Madison County paying thirty percent (30%), Holmes County paying thirty percent (30%), Yazoo County paying 30 percent (30%), and Leake County paying ten percent (10%).


IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that Mary Helen Walden shall be compensated in the following amounts: beginning October 1, 2015, she be paid an annual salary of \$52,000.00, plus the usual benefits; beginning October 1, 2016, she be paid an annual salary of \$58,000.00, plus the usual benefits; and beginning October 1, 2017, she be paid an annual salary of \$64,000.00, plus the usual benefits; and such salary and benefits shall be pro-rated between the counties of the district, with Madison County paying eighty percent (80%) and Leake County paying twenty percent (20%).

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that LaTanya Allen shall be compensated in the following amounts: beginning October 1, 2015, she be paid an annual salary of \$52,000.00, plus the usual benefits; beginning October 1, 2016, she be paid an annual salary of \$58,000.00, plus the usual benefits; and beginning October 1, 2017, she be paid an annual salary of \$64,000.00, plus the usual benefits; and such salary and benefits shall be pro-rated between the counties of the district, with Madison County paying thirty percent (30%), Holmes County paying thirty percent (30%), Yazoo County paying thirty percent (30%), and Leake County paying ten percent (10%).
