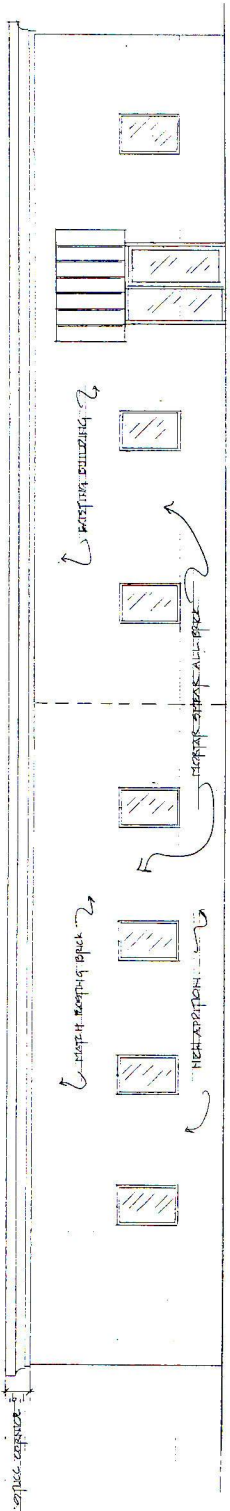

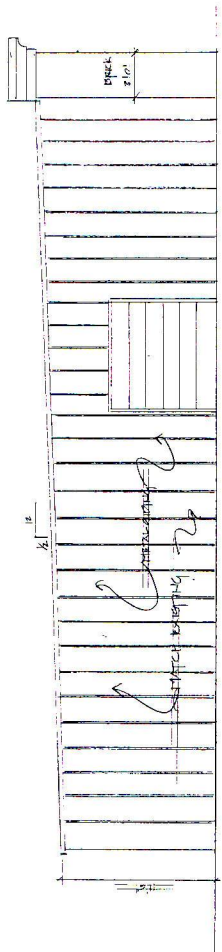

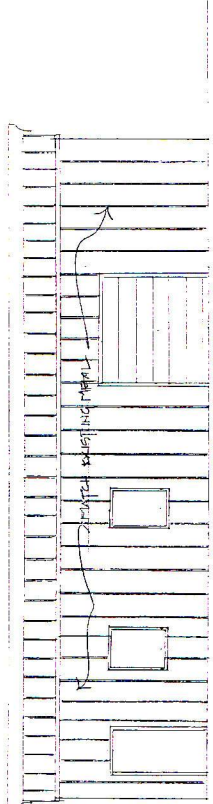


EAST ELEVATION

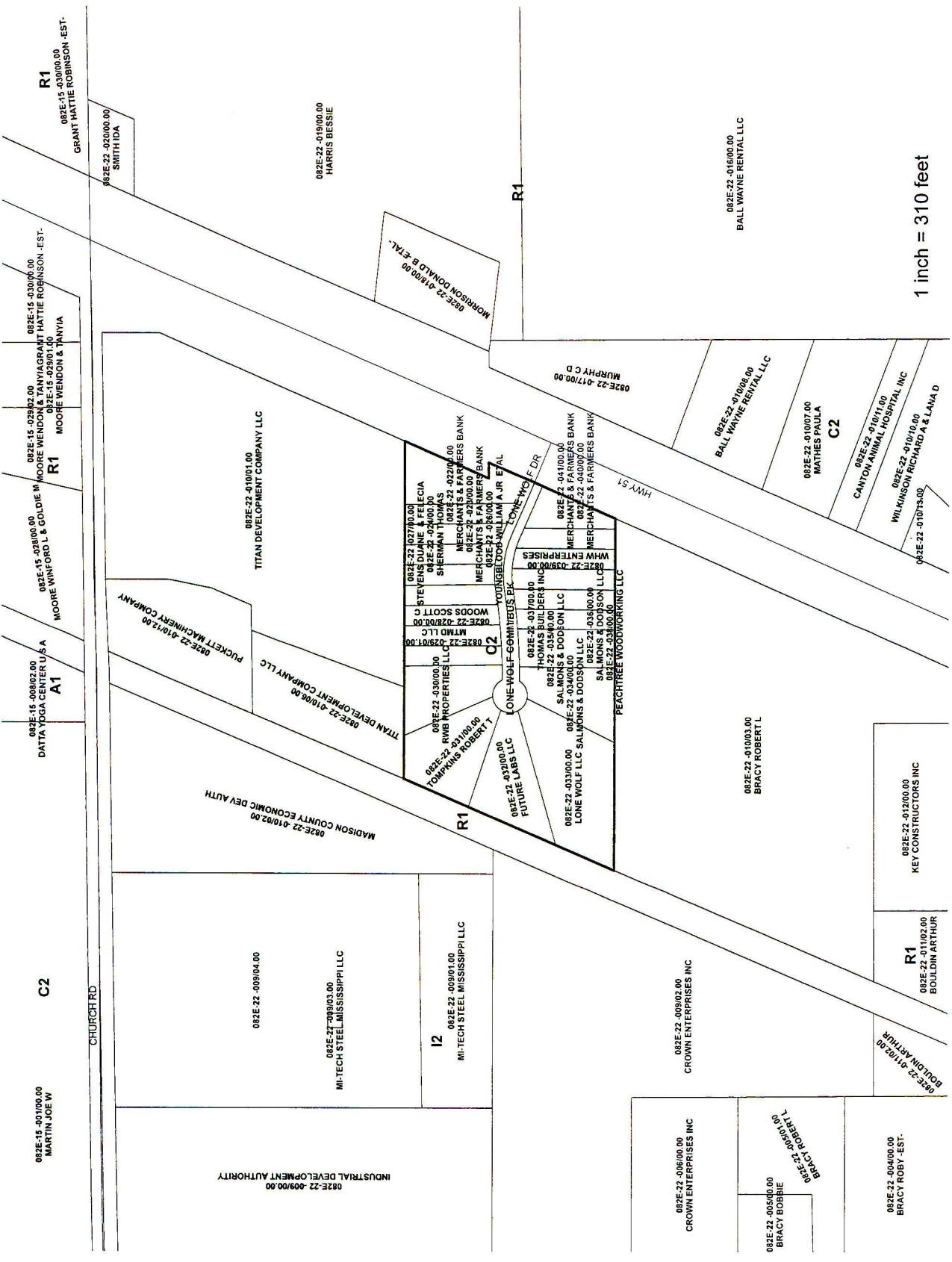


SOUTH ELEVATION
