Honorable Supervisors:


I am very conscious of the demands on your attention, however the issue presented within this notice is fundamental to our Chancery Court System.

**ORDER APPOINTING AND SETTING  
SALARY OF COURT ADMINISTRATOR**

There having come on for consideration the matter of the appointment of the court administrator of District Eleven Chancery Court, it is hereby ordered by the undersigned Chancellor that Regina Ferguson is hereby appointed to the position of Court Administrator for Senior Chancellor Cynthia Lee Brewer of the 11th Chancery Court District. It is further ordered that the salary of Regina Ferguson is hereby set at \$45,000.00 per year, plus benefits effective January 1, 2016 pursuant to the AOC Trial Court Support Staff Salary Ranges. Said salary shall remain in effect until further order of this Court.

The salary of said Court Administrator shall be funded on a monthly basis first by application from the AOC support staff funds of Senior Chancellor Cynthia L. Brewer and then from the funds of Madison County as follows:

Madison County: 100%
