Subject: Declaration of Sole Source for Law Enforcement-Grade Stun Guns (Tasers) and authority to issue purchase order for same

Gentlemen:

The Madison County Sheriff's Department is requesting to purchase eight Taser stun guns and associated supplies. The total amount of the requested order is \$8,142.92, which is greater than \$5,000 and would normally require written quotes from two vendors.

Law enforcement-grade stun guns were previously manufactured and sold by both Taser and Karbon Arms. Madison County had in the past obtained quotes from and purchased stun guns from both vendors. Taser sued Karbon Arms for patent infringement. In 2014, the United States District Court for the District of Delaware issued a permanent injunction in favor of Taser, effectively putting Karbon Arms out of the stun gun business. Madison County was required to return all Karbon Arms stun guns to the manufacturer.

In light of federal court injunction, I recommend that the board declare Taser International the sole source in the State of Mississippi for law enforcement-grade stun guns and authorize the issuance of a purchase order for same in the amount of \$8,142.92.

The Court, having considered the parties' Joint Stipulation for Entry of Judgment and having found good cause exists for the relief sought therein pursuant to 35 U.S.C. § 283 and Fed. R. Civ. P. 65,

IT IS HEREBY ORDERED:

1. Plaintiff TASER International, Inc. ("TASER") is the owner of all right title and interest to U.S. Patent No. 6,999,295 ("the '295 patent"), U.S. Patent No. 7,782,592 ("the '592 patent"), and U.S. Patent No. 7,800,885 ("the '885 patent").
2. Defendant Karbon Arms, LLC ("Karbon Arms") shall continue to be bound by the Permanent Injunction entered in the case styled *TASER International, Inc. v. Stinger Systems, Inc.*, C.A. No. 07-0042 in the United States District Court for the District of Arizona.
3. Karbon Arms, together with its current and former officers, agents, members, managers, parents, subsidiaries, affiliates, shareholders, directors, predecessors, successors, assigns, servants, employees, consultants, engineers, and attorneys, and those persons in active concert or participation with them who receive actual notice of this Permanent Injunction, are hereby restrained and enjoined, pursuant to 35 U.S.C. § 283 and Fed. R. Civ. P. 65, from

making, using, offering to sell, or selling in or from the United States, or importing into the United States, the Karbon Arms MPID and MPID-C¹, either alone or in combination with any other product, and all other products that are only colorably different from the MPID and MPID-C in the context of claim 2 of the '295 patent, claims 1, 9, 10, 11, 40 and 41 of the '592 patent and claims 7, 8, 9, 10, 12, 15, 18-27, 28 and 29-37 of the '885 patent, whether individually or in combination with other products or as part of another product, and from otherwise infringing, contributing to the infringement of, or inducing others to infringe claim 2 of the '295 patent, claims 1, 9, 10, 11, 40 and 41 of the '592 patent or claims 7, 8, 9, 10, 12, 15, 18-27, 28 and 29-37 of the '885 patent.

4. Karbon Arms, together with its current and former officers, agents, members, managers, parents, subsidiaries, affiliates, shareholders, directors, predecessors, successors, assigns, servants, employees, consultants, engineers, and attorneys, and those persons in active concert or participation with them who receive actual notice of this Permanent Injunction, are hereby restrained and enjoined, pursuant to 35 U.S.C. § 283 and Fed. R. Civ. P. 65, from supplying or causing to be supplied from the United States a substantial portion of the components needed to make, or any components that are especially made or especially adapted for use in, the Karbon Arms MPID or MPID-C or any product that is only colorably different from the MPID and MPID-C in the context of claim 2 of the '295 patent, claims 1, 9, 10, 11, 40 and 41 of the '592 patent and claims 7, 8, 9, 10, 12, 15, 18-27, 28 and 29-37 of the '885 patent.

5. Within 30 days from the entry of this Permanent Injunction, Karbon Arms shall send written notice of this Permanent Injunction to:

¹ The Karbon Arms MPID and MPID-C shall include all Conducted Electrical Weapons ("CEWs") encompassed in the definition of Accused Products, including Representative Accused Products, in the parties' Joint Stipulation for Entry of Judgment.


- A. The employees, officers, members, managers, consultants, engineers and creditors of Karbon Arms as of November 1, 2013 and as of January 9, 2014;
- B. Electronic Design Associates;
- C. Each authorized distributor, each authorized dealer, each authorized reseller, each authorized sales representative, each certified MPID or MPID-C instructor, and each certified MPID or MPID-C armorer as of November 1, 2013 and as of January 9, 2014.

6. Karbon Arms shall provide to TASER within 3 business days of entry of this Permanent Injunction a list of Karbon Arms' customers from November 11, 2010 to the present that includes the following information: customer, agency name, city, state and, if known, contact e-mail address.

7. This Permanent Injunction shall expire upon the expiration of the last to expire of the '295, '592 and '885 patents.

8. The Court shall retain jurisdiction over Karbon Arms and its current and former officers, agents, members, managers, parents, subsidiaries, affiliates, shareholders, directors, predecessors, successors, assigns, servants, employees, consultants, engineers, and attorneys to enforce any and all aspects of this Permanent Injunction.

TASER Awarded Permanent Injunction and Judgment Against Karbon Arms for Patent Infringement

Judgment Entered for \$2.3 Million Damages

SCOTTSDALE, AZ -- (Marketwired) -- 01/14/14 -- [TASER International](#) (NASDAQ: TASR) today announced that the United States District Court for the District of Delaware entered a final judgment on January 10, 2014 in the patent infringement litigation entitled TASER International v. Karbon Arms, LLC awarding TASER a permanent injunction. The Court's final judgment decreed that Karbon Arms' MPID and MPID-C conducted electrical weapons infringe TASER's U.S. Patent Numbers 6,999,295; 7,782,592 and 7,800,885. The Court further decreed that the above referenced TASER patents are valid and enforceable and awarded TASER \$2,385,366 in damages for infringement.

The permanent injunction restrains and enjoins Karbon Arms and its current and former officers, agents, directors, employees, and affiliates and those persons in participation with them who receive actual notice of the injunction from making, using, offering to sell or selling the Karbon Arms MPID and MPID-C or supplying a substantial portion of the components that are used in the Karbon Arms devices. The permanent injunction requires Karbon Arms to send written notice of the injunction to each distributor, dealer, sales representative, certified MPID or MPID-C instructor or armorer within 30 days of January 10, 2014.

"TASER aggressively pursues any infringement of its extensive patent and intellectual property portfolio and is very pleased that the U.S. District Court entered a permanent injunction and judgment against Karbon Arms for infringement of TASER's patents," said Doug Klint, TASER's President and General Counsel. "This final judgment brings to a close more than six years of various patent litigations between TASER and Karbon Arms and Karbon Arms' predecessor company Stinger Systems, Inc. The Court's order requires Karbon Arms to provide TASER a list of customers who purchased a Karbon Arms MPID or MPID-C within three business days of January 10, 2014 and TASER will be sending notice of the permanent injunction to all such Karbon Arms customers. The company is evaluating the collectability of the judgment," concluded Klint.

Sheriff's deputies have stun guns again

Months after their stun guns were taken away due to a court order citing patent infringement, Marion County sheriff's deputies are now carrying Tasers, one of the tools they say is vital to doing their job.

On Saturday morning, deputies were issued Taser X26P stun guns, holsters, batteries and cartridges.

Authorities say all patrol deputies will be getting Tasers — 186 in all — and the accessories that go with them.

To get the Tasers, sheriff's officials had to finance the deal through the company they were getting the Tasers from at a cost of \$230,159.58. Authorities made their first payment, \$48,640.95, at the end of March, and for the next four years are expected to make similar annual payments. The interest on the \$230,159.58 is \$13,045.17, officials said. With the finance agreement, sheriff's officials got a five-year warranty.

"Sheriff Blair made it a priority of finding a way to purchase the Tasers due to the significance of risk to the public and our deputies," said Capt. James Pogue, spokesperson for the MCSO.

Among the features on the new Taser is that it won't allow someone to use the device after five seconds without pulling the trigger again. With the old stun gun, the shooter could continue to hold the trigger and the cycle would continue.

In early January, the U.S. District Court for the District of Delaware entered a final judgment and permanent injunction against Karbon Arms LLC in reference to patent infringement with TASER International Inc., which manufactures the Taser brand stun gun.

The injunction prevents Karbon, or anyone working with the company, from making, using, offering to sell, selling or importing the stun guns that Karbon manufactures.

Karbon was ordered to provide TASER International Inc. with a list of customers who received their product. That list included the Marion and Levy County Sheriff's Offices.

After the ruling, TASER International sent a letter to the Sheriff's Office informing it that, pursuant to the court action, deputies cannot use Karbon Arms stun guns.

Taser is an acronym for Thomas A. Swift's Electric Rifle. The generic term for such a weapon is stun gun.

Locally, only the MCSO was affected, as the Ocala, Belleview and Dunnellon police departments, and the Florida Highway Patrol, all use products made by TASER International.

Sheriff's Office officials said they had purchased 186 Karbon Arms units in October 2012. The cost for each unit, not including the cartridge, holster and other accessories, was \$395.91. Most of the units went to the patrol division.


