Notice is hereby given of the opportunity for citizens of Rankin County as well as other interested parties to provide comment and attend a public hearing to discuss the adoption and implementation of the updated Rankin County Solid Waste Management Plan. The Rankin County Board of Supervisors is responsible for preparing the plan under state law The Solid Waste to include the entire county and participating municipalities. Management Plan is intended to contribute to the quality of life for Rankin County citizens by ensuring proper management of solid waste. The plan assesses current waste disposal needs and available options, and attempts to identify and plan for future needs. Planning for management of solid waste is vital for ensuring availability of effective and affordable waste disposal. The plan includes considerations for collection and disposal of household garbage, limbs, and bulky items such as appliances, as well as for emergency The plan identifies waste management facilities and services debris management. available to Rankin County citizens including rubbish disposal, waste tire disposal, household hazardous waste disposal, and recycling.
