**ORDER REGARDING COMPENSATION  
OF OFFICIAL COURT REPORTERS**

**THIS MATTER** came before the Court regarding compensation of the Official Court Reporters for the County Court of Madison County, Mississippi, Laurie Abraham.

Consistent with the applicable statute, the Court finds that beginning February 8, 2016, Laurie Abraham be paid an annual salary of \$52,000.00, plus the usual benefits; that beginning February 8, 2017, Laurie Abraham be paid an annual salary of \$58,000.00, plus the usual benefits; and that beginning February 8, 2018, Laurie Abraham be paid an annual salary of \$64,000.00, plus the usual benefits.

**IT IS FURTHER ORDERED** that Laurie Abraham shall be compensated in the following amounts beginning February 8, 2016, she be paid an annual salary of \$52,000.00, plus the usual benefits; beginning February 8, 2017, she be paid an annual salary of \$58,000.0, plus the usual benefits; and beginning February 8, 2018 she be paid an annual salary of \$64,000.00, plus the usual benefits.
