
**SUBJECT:** Street Name Corrections (Drawing Attached)

Ok... If you pull the following filed plats, all of them touch the road in question. There are 3 names for this road in the course of 7 plats. There is not distinction to which is correct nor if one of these cut off and turn into something else. Pull the following:

Countryside Plantation 1- (name is Countryside Pl)  
North Place Reserve- (County Barn Rd.)  
North Place 6- (County Barn Rd.)  
North Place 2- (Hawthorne)  
North Place 1C- (Hawthorne)  
North Place 1A- (Hawthorne)  
North Place 1B- (Hawthorne)

Now the parcel in question falls along the section of North Place Reserve. Although this piece of property in question is not platted, that road is in this section. In this section it referred to County Barn Rd. If it was changed, there was never any amendments to reflect that. To furthermore the issue, IF it is not supposed to be Hawthorne, the property adjacent to it has a Hawthorne address. And last but not least, where exactly does Countryside Place begin?

There needs to be a clarification of these few things and after a determined clarification is made, depending on what that looks like the next step is to move forward with making proper changes.
