RE: State Aid Budget Reductions for Fiscal Year 2016

At the end of December 2015, revenue collections in the state's General Fund were below what was estimated for State Fiscal Year 2016. Revenue collections were also below the revenue estimate for FY 2015, creating a shortfall in the beginning cash going into FY 2016. Unfortunately, because of these shortfalls, it was necessary for the state to implement statewide budget reductions to each agency in accordance with Miss. Code Ann. § 27-104-13. The attached chart shows the amount that was reduced from each county by formula. This reduction was reflected in the January Status of Funds.
