Subject: Approve monthly service fees for GPS tracking and locating devices with Fleetistics

Dear Board Members:

County Engineer & Road Manager Dan Gaillet requested to purchase 21 GPS tracking devices and 12 GPS locating devices to be installed on Road Department equipment.

The GPS tracking devices report all locations and speeds. They would be used primarily on dump trucks, tractor trucks, and motor graders. The GPS locating devices only report location. They would be used on slow-moving heavy equipment such as bulldozers, backhoes, paving equipment, and tractors. The reported GPS data can be checked by Mr. Gaillet at his will by logging into Fleetistics' website.

The total cost of the above equipment would be \$4.959.80 (see attached requisition). It would be bought through the normal purchase order process. The monthly GPS fee is \$25 per month per unit for the tracking devices (GO7) and \$14.56 per month per unit for the GPS locating devices. There is also a 90-cent per device monthly network service fee. The monthly fee agreement would be approximately \$911.10 per month, and requires board approval.
