MEMORANDUM OF UNDERSTANDING BETWEEN THE MISSISSIPPI TRANSPORTATION COMMISSION AND THE COUNTY OF MADISON, MISSISSIPPI

This Memorandum of Understanding (Agreement) is executed by and between the Mississippi Transportation Commission, a body corporate of the State of Mississippi (Commission), acting by and through the duly authorized Executive Director of the Mississippi Department of Transportation (MDOT) and the County of Madison, Mississippi (County), a municipal corporation, acting by and through its President as directed by its Board of Supervisors, and effective as of the date latest execution below.

WITNESSETH:

WHEREAS, the Commission has requested the County to grant access to modify the traffic signal equipment at the intersections of Gluckstadt Road at Calhoun Station Parkway, Gluckstadt Road at Industrial Drive South, and Gluckstadt Road at Weisenberger Road, and to provide timing synchronicity with the MDOT-owned traffic signals at the intersections of Gluckstadt Road and the Interstate 55 (I-55) ramps on both the East and West sides of I-55; and

WHEREAS, the Commission recognizes that the maintenance and the operation of traffic signals, or signal systems, are necessary to obtain a greater degree of safety and promote safe and efficient highway use and transportation along the State Highway System, or along roads and highways which connect to, and/or affect traffic on, the State Highway System; and

WHEREAS, the Commission has the authority under Section 65-1-8 and 65-1-27, Mississippi Code, 1972, as amended, to cooperate with the County for the modification of the signal control equipment, so as to provide a greater degree of safety and improve the safe flow of traffic along the State Highway System, or for traffic signals along roads and highways which connect to, and affect the safety and flow of traffic on, the State Highway System; and

WHEREAS, the Commission and the County both wish to provide a greater degree of safety for motorists using said roads and highways and to promote improved traffic progression through the aforementioned areas; and

WHEREAS, the County and the Commission agree that as a part of Project Number: SP-6989-00(001), 107156/101000, (the Project), MDOT will modify the signal control equipment at the intersections of Gluckstadt Road at Calhoun Station Parkway, Gluckstadt Road at Industrial Drive South, and Gluckstadt Road at Weisenberger Road, which affects the flow of traffic for the entrance to and the exit from I-55 and will be incorporated into an overall coordinated signal timing plan, so as to synchronize the traffic signals on, Gluckstadt Road at Calhoun Station Parkway, Gluckstadt Road at Industrial Drive South, and Gluckstadt Road at Weisenberger Road with the traffic signals at I-55 East and West ramps. At the completion of the Project, the County will retain ownership and operational control, including the signal timings, of the traffic signal equipment at the intersection of Gluckstadt Road at Calhoun Station

Parkway, Gluckstadt Road at Industrial Drive South, and Gluckstadt Road at Weisenberger Road, and will continue to be responsible for the maintenance of the aforementioned County-owned traffic signals. MDOT shall assume operational control of the traffic signal timings and coordination with the MDOT-owned traffic signals at the intersections of Gluckstadt Road and the East and West ramps for exit and entrance on I-55; and

WHEREAS, the County, by and through its Board of Supervisors, and the Commission have determined and agreed that it is in the best interest of the public for MDOT and its contractors, as part of the Project, to be allowed to modify the signal control equipment at the intersections of Gluckstadt Road at Calhoun Station Parkway, Gluckstadt Road at Industrial Drive South, and Gluckstadt Road at Weisenberger Road, and to provide signal synchronization to the aforementioned traffic signals, so as to be synchronized to the traffic signals at the intersections of Gluckstadt Road and the entrance and exit ramps, both East and West, of I-55.

NOW THEREFORE, in consideration of the premises and the mutual covenants contained herein to be undertaken by the respective parties hereto, and for other good and valuable consideration, the sufficiency of which is hereby acknowledged, the parties mutually agree and covenant as follows:

I. THE COUNTY WILL:

- A. Grant MDOT personnel and contractors access to the traffic signals at the intersections of Gluckstadt Road at Calhoun Station Parkway, Gluckstadt Road at Industrial Drive South, and Gluckstadt Road at Weisenberger Road in order to modify the County-owned traffic signals so as to incorporate said signal timings into an overall coordinated signal timing plan with the MDOT-owned traffic signals at Gluckstadt Road and the I-55 ramps on both the East and West sides of I-55; and
- **B.** Upon completion of the Project, accept responsibility and maintenance, including operations control, for all County-owned traffic signal equipment at the intersections of Gluckstadt Road at Calhoun Station Parkway, Gluckstadt Road at Industrial Drive South, and Gluckstadt Road at Weisenberger Road, including any new hardware, and acknowledge that said traffic equipment will remain the property of the County.

II. THE COMMISSION WILL:

- A. Modify the signal control equipment to incorporate and synchronize the County-owned traffic signals at the intersections of Gluckstadt Road at Calhoun Station Parkway, Gluckstadt Road at Industrial Drive South, and Gluckstadt Road at Weisenberger Road into an overall coordinated signal timing plan in synchronicity with the MDOT-owned traffic signals at the intersections of Gluckstadt Road and the exit and entrance ramps, on both the East and the West sides of I-55; and
- **B.** At the completion of the aforementioned phase of the Project and the coordination of the signal timing plan, relinquish control and maintenance of traffic signals at the intersections of Gluckstadt Road at Calhoun Station Parkway, Gluckstadt Road at Industrial Drive South, and Gluckstadt Road at Weisenberger Road.

III. **PURPOSE**

The purpose of this Agreement is to establish and define the respective responsibilities, obligations, and agreements of the Commission and the County with respect to the modification of the signal control equipment at the intersections of Gluckstadt Road at Calhoun Station Parkway, Gluckstadt Road at Industrial Drive South, and Gluckstadt Road at Weisenberger Road, which affects the safe flow of traffic for the entrance to, and the exit from, I-55, and to provide signal synchronization to the aforementioned traffic signals which will be incorporated into an overall coordinated signal timing plan with the MDOT-owned traffic signals on Gluckstadt Road.

It is understood by both parties that the Commission executes all its orders and directives through the Executive Director of MDOT. It is understood by both parties that the County executes all of its orders and directives through its Board of Supervisors President.

C.
